A. CALL TO ORDER

Dr. Gillard called the meeting to order at 6:01p.m.

LEGAL MATTERS

D. REVIEW, CONSIDERATION AND POSSIBLE ACTION ON PROPOSED BOARD ORDER ARISING FROM ADMINISTRATIVE LAW JUDGE'S RECOMMENDED DECISION

1. MD-14-1140A, MD-15-0771A, CRAIG W. TOLLESON, M.D., LIC. #36928

Dr. Tolleson participated telephonically. Anne Froedge, AAG was present on behalf of the State. Elizabeth Campbell, AAG was present as the Board's Independent Legal Advisor.

Ms. Froedge summarized that case MD-14-1140A was opened after the Board received a complaint regarding Dr. Tolleson's care of patient BB. The initial report stated that BB died from multiple drug intoxication however, the Medical Consultant ("MC") did not fault

Dr. Tolleson with BB's death. The MC found multiple deviations in Dr. Tolleson's prescribing practices and inadequate medical recordkeeping. Dr. Tolleson was unable to provide multiple charts for review as requested and was provided multiple extensions throughout the investigation due to personal concerns. Dr. Tolleson entered into an Interim Consent Agreement for Practice Restriction and agreed to participate in a competency evaluation ("ICA"). Dr. Tolleson did not complete an evaluation and subsequently violated the ICA by signing a medical certification for a patient. MD-15-0771A was opened due to Dr. Tolleson's failure to report a DUI from 2009. The Administrative Law Judge ("ALJ") found unprofessional conduct and recommended license revocation. The State requested that the Board accept the ALJ's recommended decision with minimal modifications as proposed by the State.

Dr. Tolleson explained to the Board his thought process throughout the investigation as well as the signed medical certification that resulted in the violation of the ICA. Dr. Tolleson requested further review of his case.

Ms. Froedge reiterated that the MC and ALJ did not fault Dr. Tolleson for BB's death but had concerns with his prescribing practices, documentation and justification for the prescribing that occurred. With regards to the ICA violation, Ms. Froedge noted that Dr. Tolleson's conduct constituted the practice of medicine, noting that the certification was signed after the effective date of the ICA.

MOTION: Dr. Krahn moved to accept the ALJ's proposed Findings of Fact to include the proposed modifications by the State.

Dr. Gillard summarized that this was a malpractice case regarding an error in chemotherapy dosage. Dr. Gillard noted that a very small amount was given due to a

computer error and that there was no patient harm. Dr. Gillard commented that the physician has taken remedial steps to prevent this from occurring again and opined that an Advisory Letter may not be warranted. Dr. Beyer agreed that the physician has taken adequate steps to remedy the concern.

Dr. Paul found it mitigating that Dr. Taetle has had no prior Board action.

Dr. Gillard summarized that this was a malpractice case regarding a rare virus that resulted in a terrible outcome. Dr. Gillard summarized the patient's symptoms and noted that both the physician and the radiologist diagnosed pneumonia based on the symptoms and testing. Dr. Gillard opined this is a case of hindsight and that the physician did not error in this case. Dr. Figge commented that this was an unusual case and that the argument does not dispute the facts of the vital signs. Dr. Gillard opined that the physician met the standard of care.

RESOLUTION: Issue an Advisory Letter for failing to perform an ophthalmoscopic examination and for failing to document a discussion with the on-call ophthalmologist for a patient presenting with a sudden, painless loss of vision in one eye. While there is insufficient evidence to support disciplinary action, the board believes that continuation of the activities that led to the investigation may result in further board action against the licensee.

RESOLUTION: Issue an Advisory Letter for failure to timely aspirate a seroma that developed as a post-operative complication from surgical excision of excess breast glandular tissue for a patient with gynecomastia and for inadequate documentation. There is insufficient evidence to support discipline.

RESOLUTION: Issue an Advisory Letter for failure to query the CSPMP database when issuing medical marijuana certifications. While the licensee has demonstrated substantial compliance through rehabilitation or remediation that has mitigated the need for disciplinary action, the board believes that repetition of the activities that led to the investigation may result in further board action against the licensee.

S.G. addressed the Board during the Public Statements portion of the meeting.

Dr. Gillard summarized that this case is regarding failure to diagnose a perforated colon in a patient with persistent abdominal pain. Dr. Gillard expressed concern regarding the lack of time spent or attempts to diagnose the cause of abdominal pain. Dr. Gillard noted no labs or imaging was completed and opined that this case should be returned for further investigation to discuss a recommendation for disciplinary action. Dr. Farmer agreed that there was a lack of workup completed in this case. Dr. Gillard commented that in a geriatric population abdominal pain must be investigated and a complete workup done.

MOTION: Dr. Farmer moved to offer the physician a consent agreement for a Letter of Reprimand and Probation to complete the continuing medical education ("CME") as recommended by the Staff Investigational Review Committee ("SIRC").

SECOND: Ms. Dorrell.

Dr. Beyer agreed that the care provided was not appropriate.

In one case a patient forged a prescription on a stolen pad and there were poor medical records. Dr. Gillard noted that the physician has already completed CME.

Board staff clarified the CME recommendation made by Board staff.

MOTION: Dr. Figge moved to issue an Advisory Letter with Non-Disciplinary CME for inadequate medical records and for inappropriate benzodiazepine prescribing. There is insufficient evidence to support disciplinary action. Within six months, complete no less than 10 hours of Board staff pre-approved Category I CME in an intensive, in-person course regarding medical recordkeeping and no less than 5 hours of pre-approved Category I CME regarding benzodiazepine prescribing and treatment indications. The CME hours shall be in addition to the hours required for license renewal.
