• TIPS ON CONDUCTING A FORMAL INTERVIEW AND OFFICE OF ADMINISTRATIVE HEARINGS (OAH) PROCESSES AND PROCEDURES

Ms. Smith provided training on the formal interview and post-formal hearing procedures to resolve a case with the best possible outcome to protect the public. Ms. Smith noted the importance of the record during the formal interview when substantiating the violations and creating the Board Order.
