CONSENT AGENDA

I. CASES RECOMMENDED FOR DISMISSAL

1. MD-22-0222A, SACHIN NARAIN, M.D., LIC. #51557

Dr. Narain addressed the Board during the Public Statements portion of the meeting. A.R. addressed the Board during the Public Statements portion of the meeting.

Dr. Gillard noted that the Board heard this case in April. Photos were provided showing punctures to the right side of the neck. The patient had an ablation on the right side and was supposed to have the left side done two weeks later. The patient said that there were marks on the right side and that the physician stated he does that to get to the left side. Dr. Gillard noted the first Medical Consultant (MC) concluded that the patient's allegations that the physician performed a wrong site procedure and then attempted to cover it up were likely supported. Dr. Gillard then noted the second MC's report citing the nurses' note before and after the procedure indicating the procedure was done on the correct side. Dr. Gillard explained that this was initially recommended for an advisory letter, went back for further investigation and a new recommendation for dismissal has been made. Dr. Gillard explained that you need clear and convincing evidence for the Board to issue discipline, which would require images. Dr. Farmer noted that at the previous meeting the concern was whether or not if this warranted something more severe than an advisory letter and opined that confusion remains regarding whether or not the RFA was done on the correct side. Dr. Farmer suggested interviewing the nurse who made the notes. Dr. Figge also expressed confusion regarding the recommendation and recommended returning for another review. Dr. Krahn expressed concern regarding the physician's explanation on why there are not more records or photographs. Dr. Beyer commented that given the second MC's opinion it is not likely that there will be enough evidence for discipline. Dr. Beyer inquired if the board can still issue the advisory letter.

Ms. Smith confirmed that if the Board finds the first MC's report more persuasive than the second MC's they can issue the originally recommended advisory letter.

Dr. Gillard opined that this should be sent back for another review given the complainant's statements that when she asked about the procedure being done on the wrong side the physician responded that he did that to see the other side. Dr. Gillard opined that if this was a cover up, CME for ethics would be warranted.

Board staff explained that staff requires specific direction from the Board when sending the case back for further review so that the investigator is directed on what actions to take.

Dr. Gillard opined that the SIRC report discussion did not include why this went from an advisory letter to a dismissal.

MOTION: Dr. Gillard moved to return the case for additional review by SIRC. SECOND: Dr. Figge.

Dr. Figge opined that getting another MC review would help but SIRC should take another look given the public comments. The physician stated that he was operating the equipment without a tech and that these statements make a difference. Dr. Figge questioned why the physician would go forward with the procedure if he didn't have the appropriate staff.

Ms. Smith stated that SIRC can consider additional information but if the Board opines an advisory letter is appropriate, they may do so today. If the Board's recommendation is to send it back for further investigation, clear direction regarding the unanswered questions should be given since SIRC can only consider the record as it stands now.

Dr. Figge suggested having both MCs review the additional information and have the physician respond. Dr. Farmer spoke in favor of the motion and requested further specifics from the nurse regarding the time out and the correct cite being done. Dr. Farmer also requested clarification from the two experts comment on the approach of the right side. Dr. Farmer opined that he is not terribly concerned about a surgeon operating imaging equipment as that happens a lot and is in within the physician's purview but the documentation of the imaging would have been appropriate. Dr. Moschonas commented that anatomically using one side to reach the other side of the spine should be documented. Dr. Moschonas requested if the Board could look at similar cases to verify the physician's comments. Ms. Oswald noted that in all other instances of this case the images were maintained in the record and in this instance it was not with the explanation that the physician had to operate the equipment himself. Ms. Oswald expressed concern about the lack of retention of fluoroscopic images. Dr. Beyer spoke against the motion as there is enough ambiguity that there will not be enough evidence for discipline. Dr. Beyer spoke against dismissing the case and spoke in favor of issuing the advisory letter as originally recommended. Dr. Artz recommended that a third MC to comment on the transverse approach would be helpful. Dr. Gillard required more evaluation of the SIRC report. Dr. Krahn spoke in favor of the motion as more information is helpful to reach the appropriate end point.

2. MD-22-0933A, BRADLEY J. BOWLES, M.D., LIC. #62608

Dr. Bowles addressed the Board during the Public Statements portion of the meeting.

MOTION: Dr. Beyer moved to dismiss.

SECOND: Dr. Krahn.

VOTE: The following Board members voted in favor of the motion: Dr. Farmer, Dr. Gillard, Dr. Krahn, Dr. Artz, Ms. Bain, Dr. Bethancourt, Dr. Beyer, Ms. Dorrell, Dr. Figge, Ms. Jones, Ms. Oswald, and Dr. Moschonas.

Dr. Krahn commented that the licensee raised the issue of retaliation and noted that it is an issue of unprofessional conduct if a complaint is being made in retaliation. Dr. Krahn inquired about how that it is handled.

Ms. Smith noted that generally, complainants to the Board have qualified immunity for reports made in good faith. She further stated that in order to initiate an investigation against an individual who may have filed a complaint in bad faith, the Board would need to tie that to a violation of the medical practice act. Ms. Smith noted that in general, making a false or misleading statement to the Board in a written correspondence would be an act of unprofessional conduct.

3. MD-22-0739A, AMNON I. KAHANE, M.D., LIC. #23948

Counsel Steven Perlmutter addressed the Board during the Public Statements on behalf of the physician. Dr. Beyer stated that he knows the physician but that it will not affect his ability to adjudicate this case.

Dr. Gillard noted that this case was opened due to another case and the MC found minor deviations in prescribing but in the face of this complicated patient, found it was within the standard of care.

MOTION: Dr. Gillard moved to dismiss.

SECOND: Dr. Figge.

Dr. Figge opined that the attorney made a compelling case during the public statements. VOTE: The following Board members voted in favor of the motion: Dr. Farmer, Dr.

Gillard, Dr. Krahn, Dr. Artz, Ms. Bain, Dr. Bethancourt, Dr. Beyer, Ms. Dorrell, Dr.

RESOLUTION: Advisory Letter for inadequate documentation. While there is insufficient evidence to support disciplinary action, the board believes that continuation of the activities that led to the investigation may result in further board action against the licensee.

2. MD-23-0026A, JOEL M. MCREYNOLDS, M.D., LIC. #44301

Dr. Figge recused from this case. Dr. Farmer stated that he knows the physician but that it will not affect his ability to adjudicate this case.

RESOLUTION: Advisory Letter for failing to timely report a misdemeanor charge. While the licensee has demonstrated substantial compliance through remediation that has mitigated the need for disciplinary action, the Board believes that repetition of the activities that led to the investigation may result in further Board action against the licensee.

3. MD-22-1084A, NATHAN A. THOLL, M.D., LIC. #58585

Dr. Tholl and counsel Elizabeth Petersen addressed the Board during the Public Statements portion of the meeting.

Dr. Bethancourt noted that the MC was critical about the physician not documenting right side weakness, CVA and not referring to the nephrologist, but in the medical records it was quite clear.

MOTION: Dr. Bethancourt moved to dismiss.

4. MD-22-1047A, THOMAS S. KANG, M.D., LIC. #33713

Counsel Michele Thompson addressed the Board during the Public Statements portion of the meeting on behalf of the physician. Dr. Figge recused from this case. Dr. Farmer stated that he knows the physician but that it would not affect his ability to adjudicate the case.

Dr. Farmer stated that this is a routine procedure done in offices and can be uncomfortable. Dr. Farmer commented that he said/she said can be difficult and opined that there is no purpose served with the advisory letter. Dr. Beyer noted that the physician has made some changes to his practice since this incident, which is good but indicates that there were changes that were needed to be made and spoke in favor of the advisory letter. Ms. Oswald noted that the physician did acknowledge the template adjustment and the incomplete documentation. Ms. Oswald stated that changes were made and spoke in favor of the dismissal. Dr. Artz spoke in favor of the dismissal and commented that roughness and demeanor is not something to write a letter about.

MOTION: Dr. Farmer moved to dismiss.

Dr. Bethancourt opined that the physician had the appropriate consent to perform the procedure as it was mentioned.

6. MD-22-1121A, RON Y. MARK, M.D., LIC. #43845

RESOLUTION: Advisory Letter for failing to identify and report vertebral signal abnormalities on an MRI resulting in a delayed diagnosis of metastatic prostate cancer. While there is insufficient evidence to support disciplinary action, the board believes that continuation of the activities that led to the investigation may result in further board action against the licensee.

7. MD-22-0655A, CECILE D. DUMERVE, M.D., LIC. #46655

D.W. addressed the Board during the Public Statements portion of the meeting.

Dr. Beyer expressed sympathy for the patient but noted that the physician ordered the appropriate tests and scheduled a follow-up visit, which did not happen. Dr. Beyer opined that the physician did what he was required to do, but got caught up in a bad outcome.

MOTION: Dr. Beyer moved to dismiss. SECOND: Dr. Artz.

Dr. Gillard opined that when a physician orders a test he should review the results and therefore the advisory letter is indicated. Dr. Bethancourt agreed that the physician is obligated to report the results and that the patient needs to be notified. Dr. Artz noted that x-rays are reviewed in advance of the follow-up appointment and if the patient does not show up it is a lot of effort to track down the patient. Dr. Figge stated that this was a system error and it is unclear if this actually came to the physician's attention. The physician did mention that this would not happen again in the clinic. Dr. Figge opined that this does not rise to the level of an advisory letter. Ms. Oswald noted that the patient came back six months later and even then the MRI results were not discussed, the mother found the results using the patient portal. Ms. Oswald spoke against the motion as it was the responsibility of the physician.

While there is insufficient evidence to support disciplinary action, the board believes that continuation of the activities that led to the investigation may result in further board action against the licensee.

SECOND: Dr. Bethancourt.

Dr. Artz noted that at the six-month appointment the daughter was having pain again and that the mother could have reviewed the patient portal right after the MRI was done. Ms. Jones commented that sometimes accessing the portal can be difficult depending on the different programming. Dr. Farmer commented that it is an interesting interplay of what the physician and patient's responsibilities are when they don't follow up. Ms. Jones noted that the patient's public statements.

Dr. Gillard summarized that the parents were unhappy that the swab was sent out of state. The physician saw this patient four times in nine days for worsening symptoms and opined that the physician was not faulted for ordering a more sophisticated test.

RESOLUTION: Advisory Letter and Order for Non-Disciplinary CME for prescribing high dose opioids without a clinical rationale.
